# Section 5. Fire-fighting measures

# Section 7. Handling and storage

#### Precautions for safe handling

**Protective measures**

Wear appropriate respirator when ventilation is inadequate. Do not enter storage areas and confined spaces unless adequately ventilated. # Appropriate engineering controls
